Introduction

At **21YunBox** ("we", "us", or "our"), we value and respect your privacy. This **Privacy Policy** applies to visitors of **21CloudBox.com**, related websites under the **21CloudBox.com** or **21YunBox** domains (the "Site"), and users of our software, tools, and related services (collectively, our "Services"). This policy outlines how we collect, use, and protect personal information, and demonstrates our commitment to transparency.

By using our Services, you acknowledge that you have read and understood this **Privacy Policy** and agree to its terms, as well as our **Terms of Service**.

Defining Key Terms

In this **Privacy Policy**, the following terms are defined:

- Users: Individuals who visit our Site and customers who use our Services.
- End Users: Visitors, users, or customers of sites created by our Users.
- **Personal Information**: Any information that can be used to identify an individual, either alone or combined with other data.

Other terms used in this **Privacy Policy** follow the definitions provided in our **Terms of Service**.

Information Collected

21YunBox offers various services collectively referred to as the "Services." We collect information from individuals who visit our website ("Visitors") and individuals who register to use our Services ("Customers"). The information we collect includes:

- 1. **Required Contact Information**: Information like your name, company name, address, phone number, and email address provided when you express interest in our Services or register to use them.
- 2. **Billing Information**: Financial qualification and billing details like billing name, address, credit card number, and details about employees using the Services.
- 3. **Optional Information**: Additional data, such as company revenue, number of employees, or industry, which helps us understand your needs better.
- 4. Website Navigational Information: Information collected through cookies and web beacons, such as your browser type, IP address, and actions taken on our website (e.g., pages viewed, links clicked). This helps us improve our website experience.

5. **Employee Data**: Personal data related to our employees, such as name, address, job title, location, compensation, and employment history, used for internal purposes.

By providing any of the above information, you give 21YunBox permission to use and store it in line with this Privacy Policy.

Use of Information Collected:

21YunBox uses the information it collects for various purposes, including:

- 1. **Service Delivery**: We use the information provided by our customers to perform and deliver the services requested.
- 2. **Marketing Purposes**: We may use customer information to contact you regarding your interest in our Services and to provide you with details about 21YunBox and our partners. This could include sending marketing materials and promotional offers, subject to your preferences.
- 3. **Payment and Financial Verification**: Credit card information is used solely to verify the financial qualifications of prospective customers and to collect payments for the Services.

Referral Program: Customers and visitors may use our referral program to share the 21YunBox Website with friends. When using the referral feature, we will ask for your friend's name and email address to send a one-time invitation to visit our Website. We do not store this information after the email is sent.

Customer Testimonials: 21YunBox may display customer testimonials, which may include names, job titles, and other relevant details, on our Website. We will always obtain the customer's explicit consent before posting any testimonials or customer information.

Sharing of Information Collected

21YunBox may share customer data with our service providers, who assist us in delivering Services and communicating with users. These service providers may contact Customers or Visitors who have provided their information to 21YunBox on our behalf. We may also share customer data with service providers to enhance the quality of the Services and ensure accurate communication.

Unless stated in this Privacy Policy, 21YunBox does not sell, rent, or trade user data with third parties for promotional purposes. Occasionally, 21YunBox may partner with other companies to offer joint products or services. If you purchase or express interest in a jointly offered product or service, 21YunBox may share your data with our joint promotion partners after receiving your explicit consent.

We may also share information with third-party service providers, such as payment processors, who manage financial transactions. These providers will not store, retain, or use your billing information beyond the processing of your payments.

In some cases, 21YunBox may disclose your information if required by law, or if we reasonably believe such disclosure is necessary to protect our legal rights or comply with a court order, legal process, or law enforcement request. Employee Data will only be disclosed for Employee Data Purposes, and employees will be notified with an opportunity to opt-out or object to such use.

How Does This Privacy Policy Apply?

This Privacy Policy explains how we handle personal information that we collect and use for our own purposes (i.e., when we act as a controller), such as your account information and data

about how you use and interact with our Services. This includes information submitted to our customer support channels and any data related to your End Users.

When you use our Services, we store, process, and transmit your User Content. User Content includes any content you post or upload to our Services, such as your images. We store and process these files and information to provide our Services. This Privacy Policy does not cover what we do with User Content on behalf of our Users (where we act as a processor). If you are an End User of one of our User's sites, please refer to their privacy policy to understand how they handle your information.

What Information Do We Collect?

- Information from your use of our Services or Users' sites. This includes details such as IP addresses, browser type and version, operating system, device preferences, network or internet service provider, timestamps, referral pages, browsing behaviors, and interactions with our Services and Users' sites.
- **Partner-provided information.** To improve our Services and support marketing initiatives, we may receive information from our partners, such as when you are shown one of our ads via an advertising platform.

• Social media and website information. If you choose, you may provide additional information such as your social media profiles, personal website name, or other discretionary information.

How We Collect Personal Information

We collect personal information from various sources:

- 1. **Direct information.** You provide some of this information directly, such as when you register for an Account.
- 2. **Automatically collected information.** We collect some information automatically when you interact with our Services or Users' sites, through technologies like cookies and similar tools (including the 21YunBox speed test, 21YunBox code test, and Site Audit).
- 3. **Third-party sources.** We may receive information from third-party services, such as payment processors or services like Google, if you use them to register for an Account.

I. Personal Information You Provide

We collect personal information directly from you to provide or improve our Services. This includes details like your name and email address for registration, identity confirmation, and account management. We also collect any communications you send us (e.g., customer support inquiries or forum posts). You might also provide us with information in other ways, such as responding to surveys or submitting a form.

III. Personal Information Obtained from Other Sources

When you provide or update your payment information, we transmit it via an encrypted connection to our payment processor, Stripe. Payment Information may include your shipping and billing address, name, and email. Stripe processes this information in accordance with its own Privacy Policy.

Data Processing Agreement (DPA)

Applicability of DPA

Why Do We Collect Such Information?

We use the personal information we collect from you to:

End Users' Personal Information
